3. If the SVHC content in the product is $>0.1 \%$ of the total item weight but the amount that the importing is company is importing is <1 ton per year, the company should inform the supply chain about this fact on request. Doing a test is not mandatory but it is obliged to confirm in writing that the content of substance $x$ present in the item is $>0.1 \%$ of the weight. Notification information includes: identify of registrant, identify of substance, registration number (if available), classification and labelling, description of use (substance \& article), tonnage range (the importing company should have a report / statement available within 45 days after delivery)
4. If the SVHC content in the product is $>0.1 \%$ of the total item weight and total amount that the importing company is importing is $>1$ ton/year , the substance shall be notified to ECHA.
