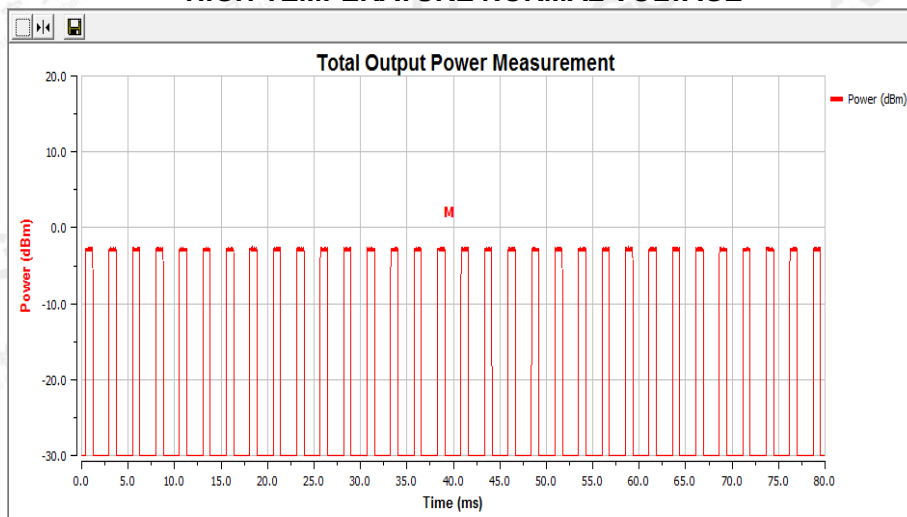

LOW TEMPERATURE NORMAL VOLTAGE



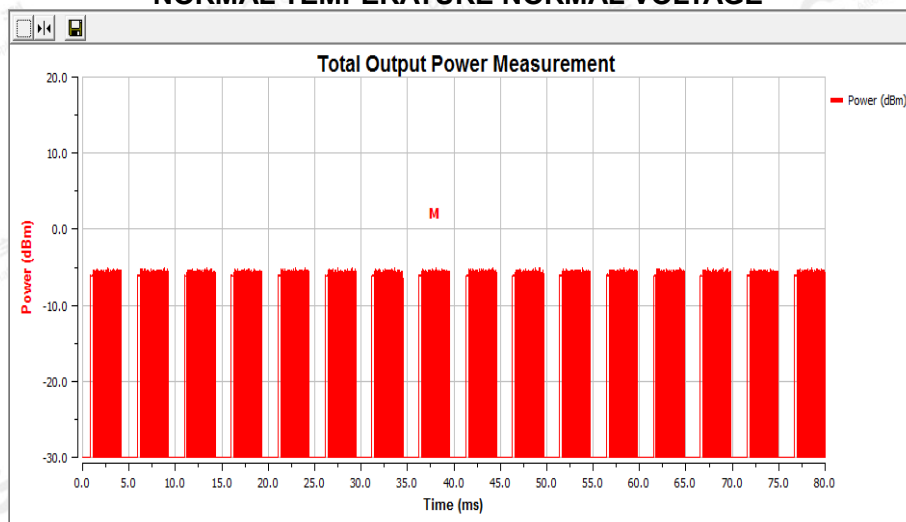
HIGH TEMPERATURE NORMAL VOLTAGE

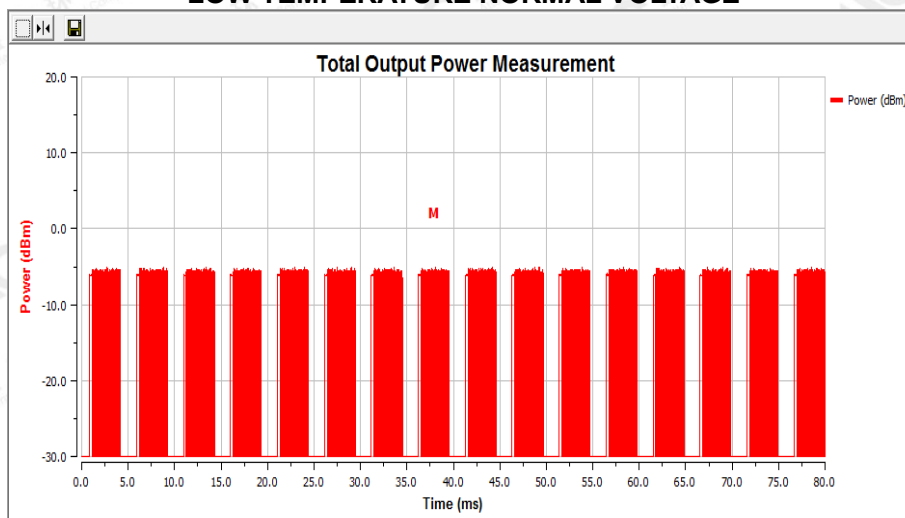

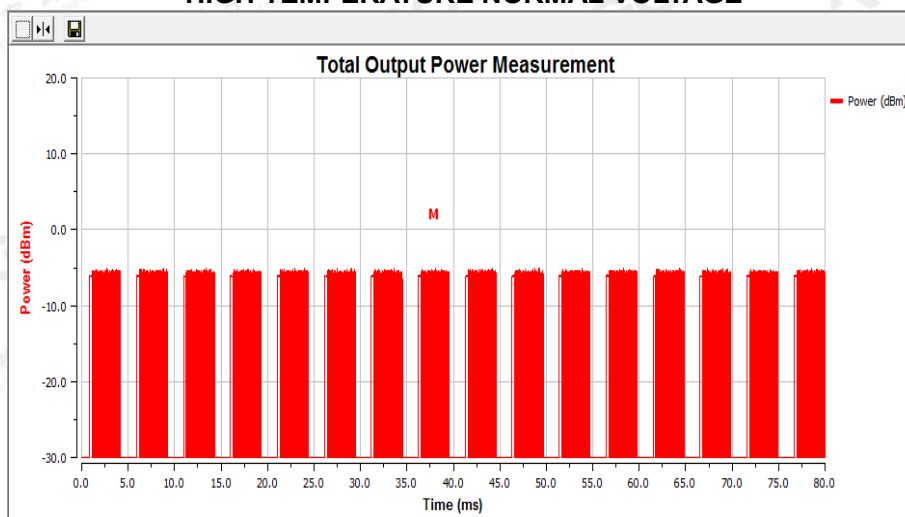

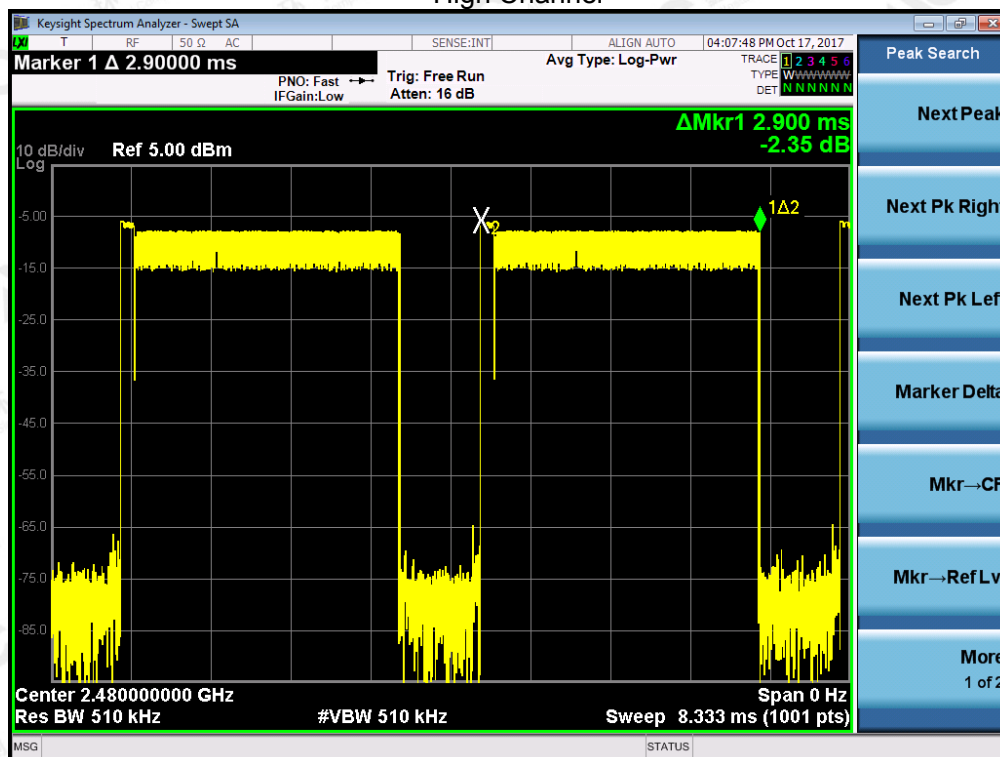

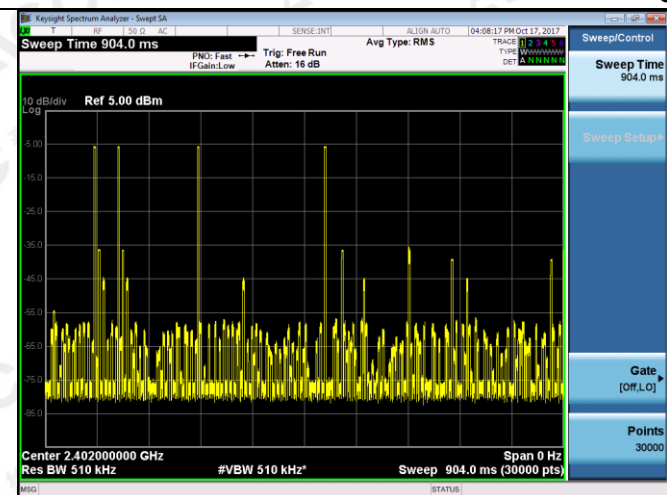

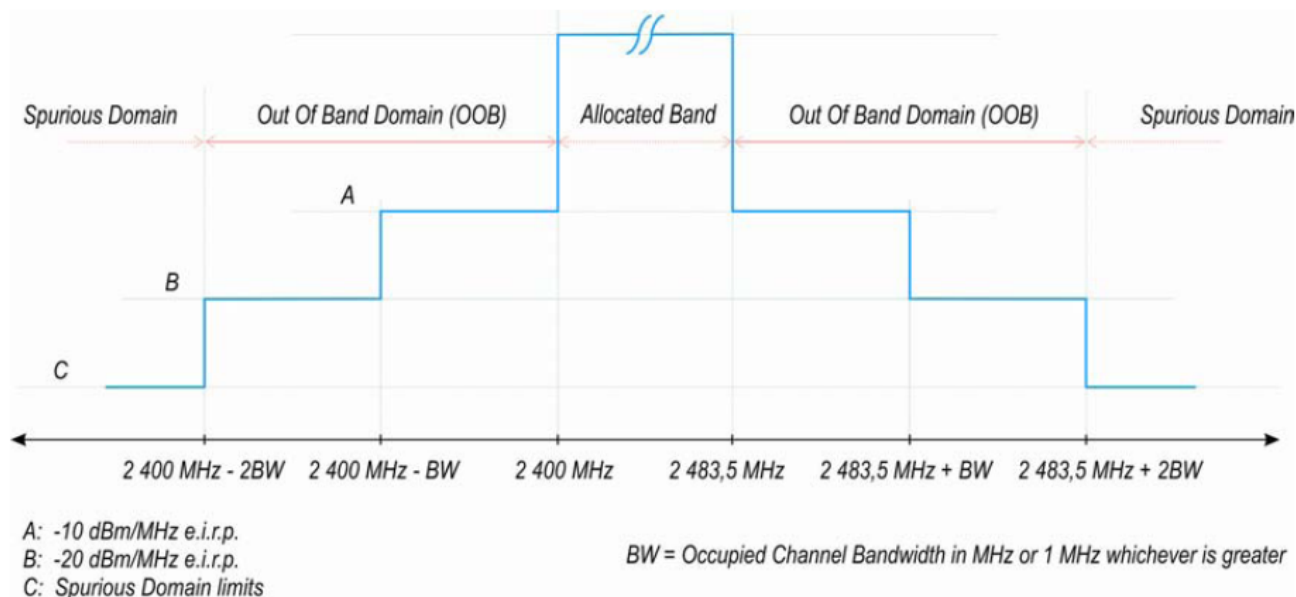
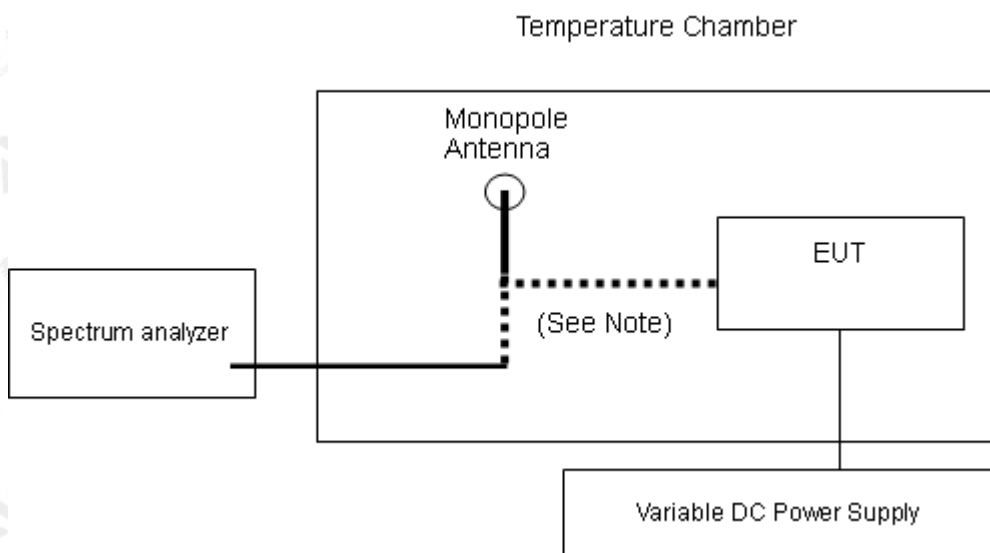


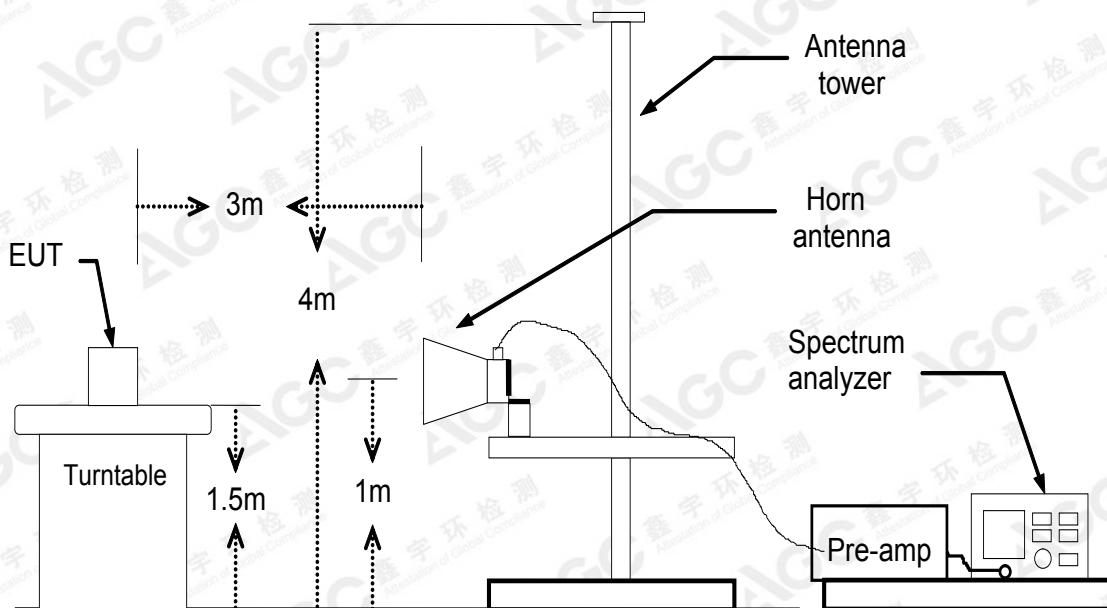
Figure 1: Transmit mask
