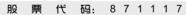

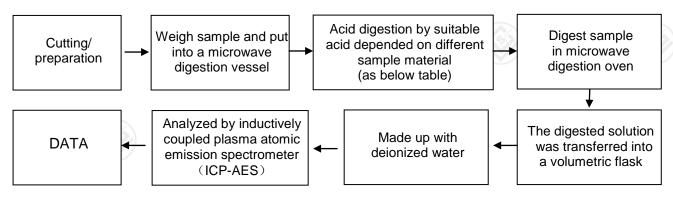

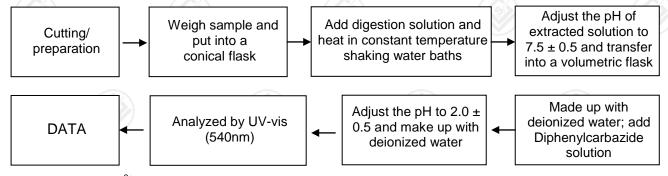

1. Test Flow chart for Cd/Pb /Hg content

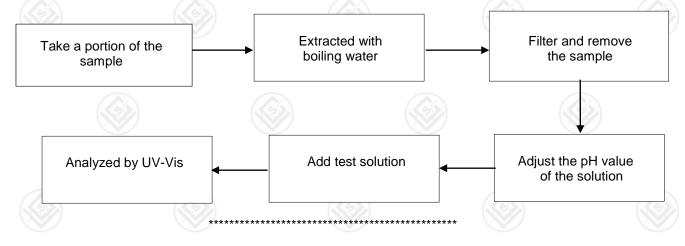


2. Test Flowchart for Cr⁶⁺ content (For non-metal material)

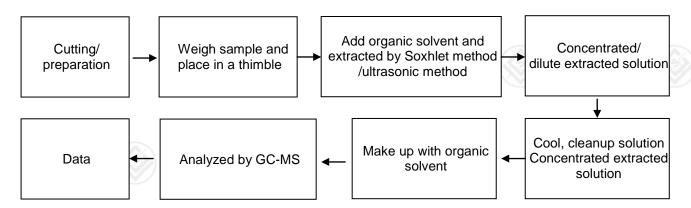

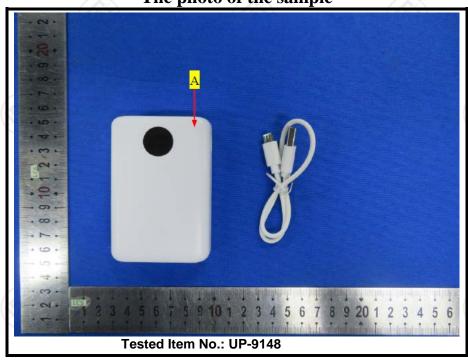
